# Mathematics

## Chapter 1: Introduction to Algebra

This chapter introduces the basic concepts of algebra, including variables, constants, and algebraic expressions.

### 1.1 Variables and Constants

Variables are symbols that represent unknown values, while constants are fixed values that do not change.

Examples of variables include  $x$ ,  $y$ , and  $z$ . Examples of constants include  $2$ ,  $5$ , and  $-3$ .

Algebraic expressions are combinations of variables, constants, and arithmetic operations.

#### Example 1

Write an algebraic expression for the sum of a number and 7.

Solution: Let the number be  $x$ . The algebraic expression is  $x + 7$ .

### 1.2 Simplifying Expressions

Like terms are terms that have the same variables raised to the same power.

Example: Simplify  $3x + 2x + 5$ .  
Solution:  $3x + 2x + 5 = 5x + 5$

Example: Simplify  $4y - 2y + 8$ .  
Solution:  $4y - 2y + 8 = 2y + 8$

Example: Simplify  $2x + 3y + 4x - y$ .  
Solution:  $2x + 3y + 4x - y = 6x + 2y$

Example: Simplify  $5x^2 + 3x - 2x^2 + 4$ .  
Solution:  $5x^2 + 3x - 2x^2 + 4 = 3x^2 + 3x + 4$

Example: Simplify  $7x - 3x + 2x^2 - 5$ .  
Solution:  $7x - 3x + 2x^2 - 5 = 4x + 2x^2 - 5$

Example: Simplify  $3x^2 + 2x - 4x^2 + 7x - 1$ .  
Solution:  $3x^2 + 2x - 4x^2 + 7x - 1 = -x^2 + 9x - 1$

Example: Simplify  $2x^3 + 5x^2 - 3x + 1 - x^3 + 4x^2$ .  
Solution:  $2x^3 + 5x^2 - 3x + 1 - x^3 + 4x^2 = x^3 + 9x^2 - 3x + 1$

**Background Information**

At the meeting of August 7, 2012, Paula Phillips, President BCCE, alleged that the District is contracting out bargaining unit work at LeConte Elementary. In particular, President Phillips stated that an

employee at LeConte was being laid off and the work he performed was being outsourced to the company Playworks. The employee at LeConte currently holds the position of Instructional Specialist, PE. In review of the job description for Instructional Specialist, the primary duties revolve around: supporting and enriching the instruction in the designated area; explaining and demonstrating instructional methods to students; assisting the certificated instructor in evaluating student learning; maintaining records of student progress and attendance; and monitoring and controlling student

behavior according to established protocols. In review of the contract between Playworks and the
